

CHANGES TO RETIREE HEALTHCARE AND OPEN ENROLMENT: As part of the 2018 Collective Bargaining Agreement (CBA) between AK Steel and the UAW, changes were negotiated to the retiree healthcare plan. These changes are being implemented only after court approval. The final order and judgment was signed by District Judge Terrence G. Berg on 08/23/2018. These changes will go into effect January 1, 2019 and impact the healthcare coverage of Severstal and AK Steel-Dearborn Works current and future retirees. This healthcare plan does not include Rouge Steel retirees who retired prior to the 2004 bankruptcy. Those retirees will remain covered, for the term of the current CBA, under the current Cluster Plan arrangement.

The negotiated changes to the retiree healthcare plans were necessary to maintain retiree healthcare for the long-term at reasonable costs. Our Voluntary Employees Beneficiary Association (VEBA) continues to pay an ever increasing portion of the cost of retiree healthcare. To ensure that the VEBA has adequate funding for current and future retirees some changes to the coverage and funding were necessary.

To provide additional information there will be a mailing sent out late September or early October that will provide a detailed explanation of the plans and associated costs. There will be an open-enrollment period between October 15 and November 15. Please look for the mailing, review your options and enroll in the appropriate plan for you, your spouse and dependents.

All three of these good brothers will be sadly missed by their families and many friends.







#### **BALLOT PROPOSAL ENDING GERRYMANDERING IN MICHIGAN**

In November there will be a proposal on the ballot to end gerrymandering in Michigan. It is very important that we encourage our friends and family to get out and vote, ending tampering with our elections. Currently, the Michigan republican legislators have gerrymandered district voting, tipping the scales in their favor. A nonpartisan group called Voters Not Politicians was created to take on this fight to make our elections fair. This ballot proposal would empower a commission made up of 13 members. This commission would consist of 4 republicans, 4 democrats, and 5 independents that would be responsible to fairly redraw the district lines.

Republican led groups have been trying to block the gerrymandering ballot proposal, but they were unsuccessful and the Michigan Supreme Court recently ruled in favor of Voters Not Politicians, to have the proposal on the November 6th ballot.

Elections should be fair and democratic. Politicians should not be able to manipulate voting maps to give themselves a favorable outcome. These politicians should appeal to their constituents to whom they are working for. Gerrymandering is unethical and should never be allowed.

This is why voting on November 6th is so important. We cannot sit silent and allow this voter suppression to take place.

UAW President Walter Reuther said it best, "There's a direct relationship between the ballot box and the bread box, and what the union fights for and wins at the bargaining table can be taken away in the legislative halls". Remember, if you don't vote, then you are allowing others to speak for you. Let's get out and vote take back Michigan!

When we vote, we win! Don't sit home on election day and allow others to steal our democracy.

The committee and I have been working with the National Ford Department on a business case to hire additional full-time employees at DDMP. Although we are hiring 19 full-time employees, I believe that number should be increased and additional hiring should take

I want our TPT and STS employees to know that I hear your concerns, I know frustrating this is for all of you and the committee and I will continue this fight until we see change!

#### WOUNDED WARRIOR FAMILY

During the week of September 17th-21st, The Wounded Warrior Family Support organization's High Five Tour 2018 visited Dearborn Stamping, Truck, Diversified Manufacturing, Engine and finally the Tool and Die Plant. The vehicle used for this year's national tour was a 2018 Ford Raptor built right here at Dearborn Truck Plant. The High Five Tour is Wounded Warriors Family Support's national fundraising activity that provides companies and communities across 48 states an opportunity to thank and show their appreciation for our service men and women and their families. The trip crisscrosses the country giving thousands of Americans an opportunity to support our nation's military families and educates the public on the sacrifices both the service member as well as well as their families face when someone is deployed, severely wounded or killed.

WWFS was founded by Colonel John D. Folsom, USMCR and he is currently president of the organization. The organizations humble beginnings started as a "pass the hat" initiative by Colonel Folsom on March 20, 2003 and with the initial \$1,500 collected, he purchased items for the Landstuhl Regional Medical Center in Germany, the first stop for U.S. armed forces personnel evacuated from Iraq and Afghanistan. Their mission statement is to support the families of our combat wounded service members with dependent children and widows of service members killed in action or as a result of wounds sustained while serving.

On behalf of our entire Local 600 Veterans Group and all the hard working brothers and sisters in the Rouge complex that are part of the process that built the 2018 Ford Raptor for the national tour, we are humbly grateful to be able to take part in such a worthwhile cause and host the vehicle here in our plants for a week.

- Local negotiations are quickly coming up and we will be sitting down with the company to discuss the Unit agreement. Submit your resolutions to your committee person
- 2019 will bring the negotiations for the CBA and we will be taking resolutions starting next year
- Mid-term elections are some of the most important we have seen in recent memory. Get out and vote; it's your right and it's your voice. It has been said, what you win at the bargaining table, you lose at the voting booth. Those are words to remember
- There has been an overtime squeeze on all aspects of the business. While we were at sub-council, retiring VP Bruce Hettle used the term "fitness" over 27 times while we kept count. That term wasn't lost on us—the squeeze was coming and it's here. The company has also offered hundreds of buyouts to salary people, in an unprecedented movement toward cutting costs and overhead.

There have been many things brought to light that, if you allow them, can shake your core beliefs. However, there is good and bad in any organization. You hope to elect those who you trust and believe have your best interest at heart. Stopping your union dues because you think that sends a message, only weakens the negotiating power of the people sitting across from the company. I truly believe that this contract will be difficult on many levels. There are people who feel disenfranchised, there are nay-sayers who have already started "vote no" committees even though there is nothing to vote on, there are people who have lost faith for one reason or another and there is apathy, which in my estimation is the most dangerous. You can vote no on anything, that is your choice. However, take the time to read and investigate and vote based on knowledge and understanding, not emotions and social media hype. 


