

LUEKEMIA & LYMPHOMA MAN OF THE YEAR NOMINEE

i, I'd like to introduce myself. My name is Martin (Marty) Glenn Uhlik. I will be 63 in May of this year; this is important to know because I was diagnosed with an advanced Testicular cancer in January of 1997 that had metastasized to both lungs. If I had not heeded my wife's wishes and gone to see my doctor, I was told I likely would not have seen my 40th birthday in May of 1997. I am a cancer survivor!

I don't share this next issue with everyone so keep it between you and me I have been fighting Chronic Kidney Disease (CKD) for about the last 14 years. I have been in Stage 4



for about the past six or seven years and am now just a few percentage points from going on dialysis and beginning the search for a kidney transplant donor.

I am not telling you all of this to have you feel sorry for me, in fact,

please don't let that cross your mind. I only gave you facts of my past and present medical history to try and underscore the importance of what follows. It is more important than any individual person, yet it is going to take many individuals to beat blood cancers.

My first grandchild, a beautiful baby girl, was born July 31st, 2015. In the months that followed, her mother, my daughter Breeana, began to lose her appetite, gain weight; she was lethargic. She was having extreme difficulty caring for her newborn child. In early November of 2015 after an exploratory surgery she was diagnosed with Stage 4 Burkitt's Non-Hodgkin's Lymphoma. She was 23.

I have been given the opportunity of a lifetime to help others. Each year, The Leukemia & Lymphoma Society (LLS) launches its Man & Woman of the Year fundraising campaign, and I was honored to join this year's efforts as a team member for Team Just keep Swimming. I am writing today to ask for your support of LLS's mission in its efforts to find cures for blood cancers and to assist patients and families as they battle this disease. From March 5th to May 16th, our team goal is to raise \$30K which will go directly to LLS in support of its longstanding goal: a world without blood cancers. If we raise \$60K by June 30th, we can link our team name to an LLS-funded research portfolio to honor our efforts to help people with blood cancers.

Like many of you, I have witnessed first-hand the debilitating effects that leukemia, lymphoma, Hodgkin's disease and myeloma can have on those who suffer from these blood cancers, and on the friends and family who care for and nurture their loved ones. However, LLS has proven that their impact is even bigger than blood cancer now, with their treatments effectively working in breast cancer, colon cancer, pancreatic cancer, prostate cancer, lung cancer, brain cancer, skin cancer, etc. Their treatments are also helping those battling with lupus, diabetes, MS, rheumatoid arthritis, autoimmune diseases, and more. There are many reasons to be proud to support LLS's efforts. For instance, of the 52 FDA approved treatments for cancer today, LLS funded research has discovered 46. This is an organization that is making an impact with the dollars it raises, and I'm proud to be associated with LLS.


imagine if all of us, everyone, took the stance that we are not leaving our homes?

BEST IN SHOW & BEST IN CLASS

AND THE WARM DETAILS OF THE 1968 MUSTANG GT

My Father William Fullerton bought this Mustang GT from one of his Union brothers at local 182, Livonia Transmission in 1997. He bought this car with the intention of restoring it with me. But as a young adult I had no interest in working on the car. I was all about partying with my friends and working.

The car is a 1968 Mustang GT all original from San Jose. California. It was the first year of the GT for the Mustang. The car came with a 390 cubic inch motor and a 4-speed manual transmission. In 2008, I finally settled down and started this process of restoration with my Dad. We took the body off the Mustang and had the absolutely rust-free car painted with a fresh coat of Gun Metal Gray. This took us about 18 months. We reassembled the car and together we enjoyed this car up until my dad started getting sick in 2011.

As my father, a Vietnam Veteran, started becoming more and more sick the car was put on the side. On August 13, 2013 my father passed away. I inherited

the car and I put it in my garage to not be touched for a little over a year. I went out one day and decided that now was the time I was going to restore this car in my father's Honor. So, I pulled the body once again and repainted it the same color with a little added flair. I pulled the motor and I rebuilt the motor and put in a 5 speed transmission. I had a mural of a fallen soldier airbrushed on the underside of the hood to honor my dad.

In 2015, after I had the car completed, I entered the car in the Detroit Autorama which was my dad's final dream for this car. I had a great weekend telling this story and reliving his memory. Since then we have

been to many car shows together and have won many trophies and awards.

One of those awards was the Best of Show 2019 here at the Local 600 UAW Car Show. I miss my father and would give anything to have one last ride with him. But I will always have this car to remember him by and I will one day pass it down to one of my boys.

LIZ JACKSON (Continued)

Her community activism included a period as vice president of the Michigan Black Caucus, a member of the Michigan Democratic Party and the Detroit Branch of the NAACP. Also, she served on the Detroit Fire Commission.

SHE DIDN'T LET RETIREMENT STOP HER

After retiring in 1983, she remained active mentoring future leaders and engaging in politics on all levels. She was active in UAW Region 1A events and doted on her beloved Local 600 active and retired friends.

In 2012, Jackson attended the Democratic National Convention as part of the Michigan delegation where she cast her vote to nominate President Barack Obama to a second term. Jackson was said to describe that event as a moment in her life that she would always remember.

On March 7, 2013, Rep. Gary Peters recognized Jackson in the Michigan House of Representatives for her lifelong achievements and contributions to the labor movement.

"Her dedication to the greater Detroit region and her brothers and sisters in organized labor have undoubtedly been an inspiration for many that have sought to serve their communities," Rep. Peters read in the resolution he presented as a representative from Michigan's 9th Congressional District. "Liz has made such a profound impact on the community she calls home and I wish her continued success in all of her future endeavors," Peters, now a U.S. senator, said at the time.

His remarks were a moving tribute to Jackson shortly after her 95th birthday. "Everyone knew who she was and what she had accomplished," said UAW Region 1A Director Chuck Browning. "Even members who did not know her personally called her Mama Liz, because they knew about her accomplishments and saw her come around, still involved and still loving her union sisters and brothers."

"She left us a great gift," President Gamble said. "Elizabeth Liz Jackson will never be forgotten. Her monumental legacy will forever be a part of what makes the UAW great."

INFLATION PROTECTION BONUS

Lump sum payment to each eligible employee will receive the inflation bonus of \$1,500 on June 14, 2020. The following eligibility rules will apply.

Eligibility Date: May 15, 2020 Amount: \$1,500 Payable During Week Ending: June 14, 2020

Eligible employees are defined as those whose status with the company as of the eligibility date is one of the following:

- Active with seniority
- On temporary layoff status
- On leave pursuant to Family and Medical Leave Act
- On leave of absence beginning not earlier than ninety (90) days prior to the eligibility date

BASE WAGE INCREASE

Employees whose straight time base hourly wage rate was \$29.52 or more as of the effective date of this agreement shall receive a three percent increase added to their base rate on September 14, 2020.

LOCAL 600 VETERANS GROUP

There are new procedures for visiting your local VA Medical Center and caution should be taken as to not infect the thousands of Veterans that rely on the VA for their health care. Please follow the guidelines below to ensure the safety of yourself and those around you.

What you should know

VA is working closely with The Centers for Disease Control and Prevention (CDC) and other federal partners, monitoring an outbreak of Novel Coronavirus which was first identified in Wuhan, Hubei Province, China. If you have flu-like symptoms such as fever, cough and shortness of breath, call before you visit your local medical center or clinic. In addition to calling first, consider using virtual care options such as telehealth or My HealtheVet Secure Messaging. Visitors, if you do not feel well, please postpone your visit to VA facilities.

VA has activated its emergency management coordination cell (EMCC) and is implementing an aggressive and collaborative public health response to protect and care for Veterans. United States is actively screening everyone who has traveled in China for this new disease. Americans who come back from the part of China where the number of infections is very high are required to limit close contact with other people and report changes in their health. VA has been planning for this type of event and is prepared to protect and care for Veterans who receive their health care from VA.

What precautions to take

Currently, there is no vaccine to prevent the CO-VID-19 infection and no medication to treat it. CDC believes symptoms appear 2 to 14 days after exposure. Avoid exposure and avoid exposing others to an infection with these simple acts.

- Learn to use VA Video Connect through the VA mobile app store or by contacting your VA care team, before any urgent problems arise.
- Wash your hands often with soap and water for at least 20 seconds. An easy way to mark the time is to hum the "Happy Birthday" song from beginning to end twice while scrubbing.
- Use an alcohol-based hand sanitizer that contains at least 60% alcohol.
- Avoid touching your eyes, nose and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick or becoming sick.
- Cover your cough or sneeze with a tissue (not your hands) and throw the tissue in the trash.

- Clean and disinfect frequently touched objects and surfaces.
- Getting a flu shot is recommended.

What to do if you have symptoms. If you have both...

- symptoms of fever, cough, and shortness of breath and
- have either recently returned from China or have direct exposure to others diagnosed with 2019-nCoV.

Call before visiting your local VA medical center to seek care or sign in to MyHealtheVet and send a Secure Message. VA telehealth options may be able to offer a prompt diagnosis and comprehensive care.

UPDATED DOD LIST IDENTIFYING AGENT ORANGE SITES OUTSIDE OF VIETNAM

The VA recently released an updated list of locations outside of Vietnam where tactical herbicides were used, tested or stored by the US military. "This update was necessary to improve accuracy and communication of information," said VA Secretary Robert Wilkie. "VA depends on DOD to provide information regarding in-service environmental exposure for disability claims based on exposure to herbicides outside of Vietnam." "DOD will continue to be responsive to the needs of our interagency partners in all matters related to taking care of both current and former service members," said Defense Secretary Mark T. Esper. "The updated list includes Agents Orange, Pink, Green, Purple, Blue and White and other chemicals and will be updated as verifiable information becomes available."

Veterans who were exposed to Agent Orange or other herbicides during service may be eligible for a variety of VA benefits, including an Agent Orange Registry health exam, health care and disability compensation for diseases associated with exposure. Their dependents and survivors may be eligible for benefits. So if you or a family member is a Vietnam Era Veteran, please go to the link: https://www.publichealth.va.gov/exposures/agentorange/locations/tests-storage/index.asp to see if you served on one of the military bases identified as storage facility.

The VA will help determine exposure after you file a claim for compensation benefits. Veterans may be eligible for a free Agent Orange Registry health exam. You don't have to file a disability compensation claim to receive the exam. Contact your local VA Environmental Health Coordinator about getting an Agent Orange Registry health exam.


